Best Practice-I

1. **Title of the Practice:** **Each One Teach One**

2. **Objectives of the Practice:**

- a. To encourage the students to participate in the mission of education for all
- b. To make them aware of the need to mitigate illiteracy
- c. To encourage the students to extend their support in community life to educate the illiterate people
- d. To encourage the students to motivate the community people to ensure child education
- e. To engage the students for effective implementation of the mission "Each One Teach One"

3. **The context:**

The college is set in a rural area; therefore, the surrounding of the college comprises of families which have illiterate members. Due to their poor economic as well as poor educational background, they harbor certain reservations regarding sending their children to schools. They prefer their children to work more than sending them to school and thus can earn money. Therefore, it is realized that there is an urgent need to take a step-in order to make people realize the importance of education in life. Since most of the parents themselves are not educated, merely arranging meetings and giving lectures would not serve the purpose. Therefore, the college has initiated a mission entitled "Each One Teach One" having an aim of education for all irrespective of any age, class or gender barriers.

4. **The practice:**

This mission would work by keeping the students at the frontline. The college authority has set a discussion on how to perform the task at hand. Thereafter, the students are given a task to perform survey in different villages to get an idea regarding people's approach toward education. Thereafter, several meetings are

organized in different villages involving the students. The students are asked to hold minimum of 4 classes per month in their respective villages among the elder people. In between, the teachers have also visited the villages to monitor the progress. After completion of a three months period, another survey was done so as to evaluate the outcomes.

5. **Evidence of Success:**

in comparison to the first survey which have very few responses in support of education, the last survey showed astoundingly beautiful results. The positive response has marked the success of the practice at hand. Moreover, the increasing number of students in the college as well as in nearby schools shows the changes that have been brought about by this practice. Another marker of change is observed in the Parents Teacher meet that is held in every year in the college. Unlike previous times, the number of the parents increased with a good number of women's presence.

6. **Problems encountered and Resources required:**

in a rural area like Krishnai, it was very difficult for the people to realise the value of education. The poor conditions of the people made them more inclined towards work rather than education. Along with poor interest in education, many people denied to take part in the first survey. The gap was big and it required time and effort to bridge the gap. However, the students have done an outstanding job by actively participating in this march. the students were the assets that made this possible. The college aims to continue such programme in near future.
