#### 9. .OPENING OF BIDS

The Sealed Envelope "A" containing the Pre-qualification bid and the Technical bid will be opened at 2:00 P.M. on 25-01-2023 at the above address in the presence of those bidders who have submitted the bids and wish to remain present. #### Forfeiture of SMD

#### 12. REJECTION OF TENDERS

### 13. VALIDITY OF PRICES QUOTED IN TENDERS

Tenders should be valid for acceptance for a period of at least 90 (ninety) days from the date of acceptance of tender by The College. Offers with lesser validity period are liable for rejection.

#### *14. DELIVERY SCHEDULE*

The stipulated delivery schedule is as follows:

The successful Bidder should deliver the equipments as per specifications within a period of **2 weeks** from the date of issuance of purchase order.

#### 15. PAYMENT TERMS

- 90% against delivery and verification of the equipment.
- Balance 10% against successful installation and commissioning of the equipment and execution of performance bank guarantee as per Annexure V.

#### 16. PENALTY

In the event of delayed delivery, installation & commissioning i.e. after the expiry of the period as agreed by both the parties, the vendor shall be liable for a penalty deduction at a percentage of the value of the undelivered equipment subject to a maximum of 5% (five percent) as detailed below:

- @ 1% up to one week;
- @ 2% up to two weeks;
- @ 4% up to three weeks;
- @ 5% for four weeks and above

For the purpose of this clause, part of the week is considered as a full week.
